<u>CONDITION OF ITEM</u>: All Items are offered for sale "AS IS", <u>NO REFUNDS</u>. The DFMWR makes no warranty, expressed or implied, as to the condition for any use or purpose and no request for adjustment in price or revision of the auction terms will be considered. Auction items are (minimum) priced based on their fair market value.

INSPECTION: The bidders are invited, urged, and cautioned to inspect each item they are interested in prior to submitting a silent bid. The items may be inspected Monday through Friday from 8:00 a.m. to 7:00 p.m. beginning March 17, 2025. Weekend bids **are** permitted from 9:00 a.m. to 3:00 p.m. **All** bids will **close** at 3:00 p.m. on March 23, 2025.

<u>BIDS</u>: All bids must be submitted in person to the MWR Davidson Fitness Center/Specker Gymnasium no later than March 23, 2025, by 3:00 p.m. <u>There are minimum bids on some</u> **items, please see bid sheet.** Bidding on each item up to **2 times** per day is allowed. The silent bids will be awarded on March 24, 2025. Winning bids will be notified by phone, with **only** 3 attempts. Marketing Office will post top five bid of each item once bids close on our MWR Facebook page.

PAYMENT: All payments will be made to **MWR Financial Management Office** by March 26, 2025. If payment hasn't been received by 3:00 p.m. March 26, 2025, Financial Management will proceed to the next Highest Bidder. Payment will be made to The MWR Financial Management Division by Visa, Mastercard, American Express, Discover, Cash or Check.

<u>REMOVAL OF PROPERTY</u>: The successful bidder will be responsible for the removal of the item. The successful bidder will be liable for any damages that might occur to Government property, as a result of moving items. The successful bidder must show proof that the item has been paid for in full before they can leave with the item. Please be sure to schedule pick up with the gym staff, accordingly. The successful bidder must have the property removed **1 week** after payment is made or by 4:00 p.m. on April 2, 2025.
